KEA decides to allot sports quota seats as promised in brochure

BENGALURU: Students seeking admissions under the sports quota for various courses under the Common Entrance Test (CET) can finally heave a sigh of relief as the Karnataka Examinations Authority (KEA) has decided to consider the list of games and sports events, which was listed in its brochure.

Students had staged a protest in front of the KEA office in Malleswaram on Monday and Tuesday after they were informed that only Olympic achievements would be considered for the sports quota seats. This came following a letter by the Department of Youth Empowerment and Sports to the KEA, seeking that the other games not be considered while allocating seats.

The KEA has now decided to offer sports quota seats to the students under all the categories as promised earlier. S NGangadharaiah, administrative officer, KEA said, "We will go ahead with the list of sports and events mentioned in the brochure that was released previously. The letter from the Department of Youth Empowerment and Sports came at the

last moment and it cannot be considered unless the rules are amended."

Navya, a Netball player and an engineering seat aspirant, said this was a sign of relief for students. "We spend several hours playing a sport. Some of us have played at international level. Not recognising this would have been unfair on the part of the KEA. We feel relieved now as we can be assured of seats in better colleges under the sports quota."

The letter by the Department of Youth Empowerment and Sports also said only stu-

dents who participated in sport activities in their second PUC or Class 12 were to be considered for sports quota. However, the KEA has said that as per the existing rules, those who have been actively participating in the list of sport events mentioned in the brochure between Class 8 and 12 would be considered.

Some students, however, claimed that they have not been informed about the change in the decision by KEA authorities. "Some students were handed over a fresh application on the spot when we

were protesting. We were told that only those eligible are being given separate applications on the spot. We are still unsure if we are being considered as we did not fill any application that day," said Sridhar, another sportsperson.

According to the KEA brochure, "The Commissioner for Youth Services and Sports or his authorised nominee is the final authority to decide the candidate's eligibility under sports category. Further, the KEA shall not be held responsible in this regard."

Fee hike of up to 8% for professional courses

Regulatory panel sets the ceiling

The fee regulatory committee, appointed by the government, has recommended a fee hike of up to 8% from the previous year for professional courses. This will be applicable for all medical, dental and engineering colleges for the 2018-19 academic year.

Justice D.V. Shylendra Kumar, committee chairman and former High Court judge, said that he conducted a meeting with private professional institutions from March 12 to March 19. "The fee fixed by the committee will act as an upper limit and ceiling," he said, adding that private institutions have the option to charge a fee lower than that fixed by the committee. In the proceedings to the colleges, the committee has allowed reasonable surplus required for the growth and the development of the institutions.

The committee has determined the fees only for institutional quota seats. He also pointed out that the seat matrix and the seat-sharing arrangement of private colleges with the government will, however, not change.

Although some colleges had projected a higher increase in expenditure, the committee was not inclined to accept the proposed fee, on the grounds that the pro-

posals are not "sustainable".

The committee has also raised objection to the manner in which consensual agreement has been entered into with private professional institutions, and noted that the fixing of fees was the function of the fee regulatory committee. "Even if the government signs the consensual agreement, it will have to fix the fee based on the ceiling recommended by the fee regulatory committee," he said. He added that government and private colleges have no choice but to implement this fee structure. "It was binding on the government to comply with it," he said.

NRI fee

The committee this year has also fixed the NRI students' fee which is 10 times the fee fixed for local students. Earlier, the State government had not fixed any cap for fees collected from NRI students.
